#### Gavin Harris, MD

Gavin H. Harris, MD is an Assistant Professor of Medicine at Emory University School of Medicine, holding appointments in both the Division of Pulmonary, Allergy and Critical Care Medicine and the Division of Infectious Diseases. He has been on faculty at Emory since 2020 and his professional expertise lies in the areas of disaster preparedness, medical countermeasures, and the treatment of special pathogens. Dr. Harris is the medical director for Education and Outreach for Emory's SCDP and one of two Critical Care Co-Liaisons for the SCDU. Additionally, Dr. Harris is an adult care subject matter expert with the National Emerging Special Pathogens Training and Education Center (NETEC), a biothreats subject matter expert with the Southern Regional Disaster Response System and a member of the Task Force for Mass Critical Care. He is currently co-chair of the Viral Hemorrhagic Fevers Critical Care Guidance National Task Force, a joint effort between the Infectious Diseases Society of America, the Task Force for Mass Critical Care, and NETEC. Dr. Harris is also an alumni fellow of the Johns Hopkins University Bloomberg School of Public Health's Center for Health Security Emerging Leaders in Biosecurity Initiative.

#### Mary Choi, MD, MPH

Dr. Mary Choi is a medical officer in Viral Special Pathogens Branch and has been with the branch since 2015. She graduated from George Washington University School of Medicine in 1999 and completed her residency training in Emergency Medicine at the University of Michigan. In 2010, she completed a fellowship in International Emergency Medicine at Columbia University where she also received her MPH in Forced Migration. She graduated from CDC's Epidemic Intelligence Service in 2014. Prior to joining CDC, Dr. Choi worked for 10 years as an emergency medicine physician at hospitals in the U.S. and overseas as an officer in the U.S. Army. Dr. Choi's emergency response experience includes serving in every CDC filovirus outbreak response since



2014, 2014 Respiratory Disease Among Unaccompanied Children Response, and 2022 Multi-National Mpox Response.

## Aneesh Mehta, MD, FIDSA, FAST

Aneesh K Mehta, MD is a professor of medicine in infectious diseases and a practicing Transplant Infectious Diseases physician at Emory University.

## Patricia Tennill, RN, BSN

Patricia Ann Tennill is the Director of Nursing at Bellevue Hospital and the Special Pathogen Program Nurse Lead. She brings her decades of experience as an ICU nurse, including first-hand experience responding to multiple special pathogen outbreaks, to lead special pathogen training and education sessions across the nation. Trish brings her expertise to shape the National Special Pathogen System of Care by serving as NETEC's Infection Prevention and Control Workgroup Chair, delivering NETEC technical consultations, and developing national guidance on special pathogen preparedness.
